### R2v3 Upstream Supplier Due Diligence – You've Had Your Audit... Now What?

he issue of upstream supplier due diligence is a common point of confusion for those certified to or pursuing certification to R2V3. Luckily, SERI's COP Advisory 22 version 1.4 outlines clear requirements for suppliers!

To quote directly from the Advisory:

- Where the R2v3 Standard provides requirements for recognizing the use of another R2 Facility as a DSV, the downstream vendor shall:
  - Actively hold an R2v3 certificate, or
  - Be R2:2013 Certified and have completed an R2v3 Transition Audit, and
  - Have a Scope of certification that covers necessary equipment, components, and materials as well as all applicable R2 Process Requirements.
- DSVs that are R2:2013 Certified but have not completed the R2v3 Transition Audit shall be qualified by the R2 Facility through the non-R2 downstream requirements in accordance with R2v3 Appendix A (8).

The need to verify suppliers as laid out in the Advisory can commonly lead to delays in the issuance of final certificates, but is vital to ensuring that the material stream is understood from start to finish. Other causes for delays can include necessary revisits to resolve NCRs, as well as prioritization in processing; more urgent certifications (e.g., nearing expiration dates, active suspensions, etc.) often come first.

SERI's expectations are high and the standard is incredibly rigorous – this is what gives R2v3 such a high degree of reputability in the recycling industry at large. The amount of scrutiny directed at audit packages is a direct consequence of that, and while PJR understands that delays can be frustrating, we will continue to do our best to support our clients and appreciate patience throughout the Transition.

\*Clients are encouraged to transition at their recertification audit. A 0.5 day of audit time is added to transition audits occurring at recertification. If clients transition at surveillance or a special audit, then 1.0 day must be added to the audit.

\*\*Only clients that transition at a recertification audit will receive a new, three-year certificate. Clients transitioning at surveillance will have their current certificate revised to reflect the new standard and possibly an extended expiration date.


